Before July 1, 2012, Virginia did not have a full-fledged set of evidence, but made do with common law and evidence-related provisions scattered in parts of the state code. The rules aim to restate existing Virginia evidentiary principles, not to change or overturn existing law.

The Virginia rules of evidence use the same numbering system used in the Federal rules of evidence for convenience purposes only. Unless a specific Federal Rule of Evidence is already incorporated in Virginia common or statutory law, the Virginia rules will not have any correlation with the federal rule.
